Population	The single family residence provides living and treatment accommodations for 6 female youth, ages 12-18. At this time there is 1 resident from Riverside County and 5 from San Bernardino County and the girls range in age from 12-17 years:

Type of Care / Treatment	They have 4 homes, 2 for girls: Jurupa Valley and Murrieta and 2 for boys: Banning and Temecula although only one is open at this time.

	Although it is an STRTP (6month treatment mode) the average length of stay is 1 year. One resident shared that she has been in several group and foster homes. She declined further comment.

How are AWOLs handled	When asked the question "what keep the youth from leaving the house, walk out the front
	door? "the answer was nothing keeps them from walking out. That told me much that the
	youth are cared for, that they're not trying to "get out of there", based on what I observed.

We couldn't get the girls to share much, for one we were in their space, plus they are teenagers they are not going to easily open up to us/strangers – I did not take it that they were afraid to share, or they didn't try to hide; that they were well and didn't want to be bothered. They were well behaved for being teenagers, I mean that in a positive sense.

When the residents were asked what they enjoyed most, several pf them agreed, "Shopping."

Incentive based programs and girls have the ability to earn additional money based on program criteria. The residents also received a monthly clothing allowance.
