**9. County Counsel Report:**

- a. The Board of Supervisors has selected Minh Tran as the new head of the Office of County Counsel. Mr. Tran is set to begin at the end of the month.

**10. Probation Report:**

- a. Institution Highlights:
- b. Population status: 138 youth
- i. AMC detention - Two boys
  - ii. Indio Juvenile Hall (IJH) – thirty boys and six girls (5 are Youth and Treatment Education Center (YTEC) and 1 is Pathways to Success (PTS).
  - iii. Southwest Juvenile Hall (SWJH) – Forty-four total (thirty-four boys and ten girls)
  - iv. 31 boys, Youth and Treatment Education Center (YTEC), 25 boys Pathways to Success (PTS)
- c. Covid Numbers:
- i. Currently, no youth are positive
  - ii. IJH and SWJH - both facilities have two staff each out with Covid-19.
- d. Fights: Total of Seven fights (Twenty this year at YTEC)
- i. Five fights at Youth and Treatment Education Center (YTEC), 2 fights at Pathways (PTS)
  - ii. Six fights at IJH
  - iii. Ten fights at SWJH (two assaults were on staff). A summary of the assaults on staff was provided along with steps taken during and after the occurrence. It was noted OC spray was deployed.
  - iv. Monthly breakdown of fights that occurred at youth institutions county wide. (Twenty fights in March, twenty-one fights in April and May, twenty-two fights in June, twenty-three fights in July).
- e. It was explained that several factors can contribute to the fights occurring, e.g., frequent change in dynamics, turn over changes of units (youth), new youths introduced to units (growing pains), gang association, etc. It was noted that 2 years ago a policy was put into place (Intervention Separation) designed to alleviate stressors by pulling individuals aside and providing services they need so they can successfully be integrated back into the group(s). Enabling staff to prevent further fights.
- f. Additional Highlights:
- i. Active recruitment for Behavioral Health Specialist BHS (Substance Abuse Counselor)
  - ii. Canine Companions, Inc. brings in a therapy dog
  - iii. Volunteers host bible studies
  - iv. Visits from 'Coach C' Martial Arts Hall of Famer and former chaplain of the Los Angeles Clippers
  - v. Employee Assistance Services (EAS)
  - vi. Counseling / Crisis Resources
- g. The Commission applauded the current Probation administration for their levels of transparency and willingness to share actual goings on within the institution units.
- h. Staffing Updates:

  - ii. Goals/Plans to reduce overtime
- i. Pathways to Success (PTS) Update (Female youth).

- i. Overall, the one female (Indio/PTS) has received a lot of programming, she is doing exceptionally well, and Indio would like to take steps to formalize off-campus activities with her.
- j. Pathways to Success (PTS) – Credit Structure:
  - i. Currently, no youth have been released thus far, but Probation fully anticipates the release of youth in the next few months based on the credit structure.
- k. Fentanyl in Youth Institutions:
  - i. New implementation of intake process
  - ii. Readily available fentanyl / opioid resistant gloves and Naloxone (Narcan) readily available
  - iii. Exploring tools to detect illicit drugs
- l. Youth Activities in Institutions:
- m. Brief overview of Title 15  
As part of Title 15 Minimum Standards, The “Recreation” time
  - i. As part of Title 15, Minimum Standards, youth shall be provided the opportunity for at least one hour of daily access to unscheduled activities such as leisure reading, letter writing, and entertainment.
  - ii. Juvenile facilities shall provide the opportunity for programs, recreation, and exercise a minimum of three hours a day during the week and five hours a day each on non-school days.
  - iii. It was noted that a wide variety of activities are available for youth choose from and Probation is always looking for vendor’s activities and ideas for youth activities.
- n. SB-821Project
  - i. Probation has met with the architect to begin the expansion of vocational class space located on the YTEC campus. Probation is really looking at ways to maximize the space so that its nimble and multi-functional for the now and for the future.
  - ii. Next step – Request for Information (RFI) response. The RFI will be used to help determine if a vendor should receive a Request for Proposal (RFP) for services.
  - iii. Probation visits to Career Training (CET) Programs in Colton, CA. CET is willing to secure funds to do a virtual component for (YTEC) on the variety of options/trades that may be available to the sophomore year youth. Junior year youth will be given the opportunity to go off ground for a thirty-day hands-on program. Probation will then look for companies willing to do an internship for senior year YTEC youth that will be willing to transition youth into employment upon release.
