### 1. CALL TO ORDER

Mark Hake called the meeting to order at 1:36 p.m.

### 2. COMMUNITY CORRECTIONS PARTNERSHIP (CCP) INTRODUCTIONS

On January 1, 2010, Penal Code Sections 1228-1233 became effective. PC1230 authorized each county to establish a Community Corrections Performance Incentive Fund (CCPIF) to improve local probation supervision practices and capacities. Additionally, PC1230 mandated the development of the Community Corrections Partnership (CCP), chaired by the Chief Probation Officer, and comprised of the following membership: the Presiding Judge of the Superior Court and a County Supervisor or the Chief Administrative Officer for the County, or their designees; the District Attorney, Public Defender, Sheriff, and a Chief of Police; the heads of the County Department of Social Services, Department of Mental Health, County Department of Employment, County Alcohol and Substance Abuse Programs, County Office of Education; a representative from a community-based organization with experience in successfully providing rehabilitative services to persons who have been convicted of a criminal offense; and an individual who represents the interests of victims.

The purpose of the CCP is to serve as an advisory role to the Probation Department in the development of a community corrections plan.

### 3. APPROVAL OF MINUTES

Mark Hake asked for a motion to approve the April 1, 2014, meeting minute. The motion was moved by Diana Walsh-Reuss, seconded by Susan Von Zabern. Minutes were approved and stand as written.

### 4. BSCC COMMUNITY RECIDIVISM REDUCTION GRANT

The Budget Act of 2014 (Chapter 25, Statutes of 2014) allocates \$8 million to the Board of State and Community Corrections for the Community Recidivism Reduction Grant described in Penal Code section 1233.10. Counties are eligible to receive funds if the Board of Supervisors, in collaboration with the county's CCP, agrees to develop a competitive grant program intended to fund community recidivism and crime reduction services. In developing the grant programs, the Board of Supervisors, in collaboration with the CCP must establish minimum requirements, funding criteria, grant award limits, and procedures for the county to award grants.

Grants must be awarded by the Board of Supervisors to a nongovernmental entity or a consortium or coalition of nongovernmental entities that provide community recidivism and crime reduction services to persons who have been released from state prison, a county jail, or a juvenile detention facility, who are under the supervision of parole or probation department, or any other person at risk of becoming involved in criminal activities. Community recidivism and crime reduction services include, but are not limited to delinquency prevention, homelessness prevention, and reentry services.

Each county's allocation is based on the population within the county. Riverside County allocation is \$500,000. This funding is available for expenditure for four years and any unspent funds revert to the state. The amount awarded to a single Community Based Organization (CBO) is \$50,000. In addition to the \$500,000, the Probation Department is adding an additional \$1 million dollars. Probation funds not expended will be return to the Probation Department.

The CCP will work with the Executive Office to create a Request for Proposal (RFP). A Community recidivism and crime reduction service provider shall have a demonstrated history of providing services to this population during the five years immediately prior to the application for a grant awarded. They shall also provide services that are designed to enable persons to whom the services are provided to refrain from engaging in crime, reconnect with family members, and contribute to their communities.

The Measurable Goal Workgroup has identified six gaps in adult services thus far:

- Transportation from prison to probation;
- Housing for sex offenders;
- Housing for females:
- Alternative treatment for mental health offenders;
- Cogitative behavior providers;
- Community recidivism and crime reduction service provider that operates Day Reporting Centers.

### 5. ROUNDTABLE

Public Defender Steve Harmon asked if the CCP Committee or possibly the CCPEC Work Group can put together a meeting to discuss Prop 47. Chief Hake offered to host a meeting to discuss the upcoming Prop 47 issue.

Division Director Maria Barajas will host a conference call on Friday, October 31, 2014, at 10:30 a.m. to discuss ideas related to the BSCC Recidivism Reduction Grant.

## PROBATION FAILURE RATE


### Old Formula

According to the Department of Finance, our weighted average baseline failure rate, established during calendar years 2006 2008, is 6.5%.

## Current Formula as of 2012

Pursuant to PC 1233, the probation failure rate for each county for the calendar year shall be calculated as the total number of from that county as a percentage of the county's average adult pursuant to paragraph (5) of subdivision (h) of Section 1170, adult felony probationers sent to prison, or to county jail felony population for that year.


## FY 2015/16 Estimated Funding (in millions)



Evidence Based Trainings Completed by Staff Annually







Successful Case Completions for Calendar Year 2014




