#### 1. Call to Order - Roll Call

The meeting was called to order by Chairman Mark Hake at 1:31 PM.

#### Roll call of the members:

Mark Hake, Chief Probation Officer, Chairman Steve Harmon, Public Defender, Vice Chairman Dave Brown, Chief of Police, Hemet (Dave Brown left the meeting early at 2:45 PM) W. Samuel Hamrick, Jr., Court Executive Officer Michael Hestrin, District Attorney Zareh Sarrafian, Assistant CEO - RUHS Stan Sniff, Sheriff

#### 2. Approval of Minutes

Mark Hake entertained a motion to approve the Community Corrections Partnership Executive Committee (CCPEC) meeting minutes dated April 5, 2016 (handout). The motion was moved by Zareh Sarrafian and seconded by Dave Brown. The motion passed as follows:

#### 3. AB 109 FY 15/16 3rd Quarter Budget Report

Chief Deputy Doug Moreno reviewed the FY 15/16 CCPEC Financial Reports for the period of July 1, 2015 to March 31, 2016 and Summary of Expenditures Schedule A (handout). The Public Defender's Office is estimating to fully expend their CCPEC allocations for FY 15/16. The Sheriff's Department, Probation Department, District Attorney's Office, and Police agencies are estimating to rollover unexpended allocations for FY 15/16. The Riverside University Health System (RUHS) is projecting a shortfall of \$4.0M. The total year-end estimated expenditures for all of the CCPEC agencies are approximately \$78.36M through June 30, 2016. The FY 15/16 Financial Reports for the 12 months ending June 30, 2016 are due August 1, 2016.

Mark Hake entertained a motion to receive and file the FY 15/16 Financial Report – Summary of Expenditures (Schedule A) and the individual CCPEC Agency Financial Reports. The motion was moved by Zareh Sarrafian and seconded by Stan Sniff. The motion passed as follows:

Aye: Hake, Brown, Harmon, Hestrin, Sarrafian, Sniff

#### 4. AB 109 FY 15/16 Revised Budget

Mark Hake stated at the last CCPEC meeting, the approval of a revised FY 15/16 budget was postponed so RUHS could provide the data to support their request for contingency funding.

Assistant Behavioral Health Director Joe Zamora distributed copies of the RUHS AB 109 Dashboard  $3^{rd}$  Quarter Staff Report (handout). He reviewed the report with data annualized to the  $3^{rd}$  Quarter as follows:

- Total Correctional Health Visits (Physician, Nurse Practitioner and Nurse visits) 14,509
- Total Behavioral Health Intensive Treatment Service Clients 160
- Behavioral Health Detention inmates screened for mental health/substance use 2,300
- Behavioral Health Detention inmates receiving on-going treatment 1,873
- Total Behavioral Health Contract Placement Services 601

Joe Zamora also reviewed the expanded Behavioral Health Outpatient Services and the medical center (acute hospital) visits/bed days. As requested at the last CCPEC meeting, he reported that the Medical Center, Correctional Health, and Behavioral Health combined budgets for FY 15/16 total \$878M. Only 2.6% (\$23.4M) of the combined budgets is funded by AB 109 dollars.

Joe Zamora stated although RUHS is not requesting replacement funding, there is an additional shortfall of \$4.6M from lost State revenue due to the unavailability of secure hospital beds previously sold to the State. Additionally, RUHS expects an increase in the FY 16/17 budget request due to settlement costs from the Prison Law Office lawsuit. They have been mandated to hire additional Behavioral and Correctional Health staff by the end of FY 16/17.

Stan Sniff advised that the secure beds were built with the intention of being used by Riverside County inmates. Although this is a loss of revenue for the County, he does not believe AB 109 funds should subsidize the Medical Center. The jails are currently at capacity and with the County's growth rate, the lockdown secured beds would have eventually been filled. Zareh Sarrafian clarified they were not attempting to use realignment dollars to make up the \$4.6M in lost state revenue, but merely to create a clear picture on the impact of AB 109 on RUHS.

Mark Hake stated when AB 109 was implemented there was discussion on the true workload attributed to realignment. It took time to determine the cost and impact on each agency. Now that RUHS is at the table and have implemented the Electronic Health Record system, they are better able to track and determine their costs due to realignment. In the future there will be tough decisions to make because there are not enough realignment monies to fund rising healthcare costs and/or any additional program implementation.

Mark Hake discussed the potential budget scenarios to be voted on by the CCPEC. The three budget scenarios are the same ones that were presented at the April 5, 2016 CCPEC meeting. There is also a request from RUHS for \$1.06M in contingency funds. Doug Moreno stated there is an additional \$4.28M that Riverside County received from the State that has not yet been allocated. He briefly reviewed the three budget scenarios summarized below (handout):

Budget Scenario 1 – Restore each agency to 100% of their respective budget requests. The remaining available balance of \$989,142 would be placed in the contingency fund.

Budget Scenario 2 – Fund each agency as approved by the CCPEC on October 6, 2015. The remaining balance of \$5.34M would be placed in the contingency fund with the option for each agency to return with sufficient supporting data and request an increase in funding.

Budget Scenario 3 – Restore each agency to 100% of their respective budget requests except the RUHS budget which will remain at an 8% reduction of their request as previously approved by the CCPEC. The remaining balance of \$3.03M would be placed in the contingency fund. RUHS may return to the CCPEC with supporting data and request to fully restore their funding.

Mark Hake stated the three scenarios were created prior to receiving the 3<sup>rd</sup> Quarter Budget Report and before knowing there would be unexpended allocations. He does not suggest Budget Scenario 1 as the majority of the agencies are projecting to roll over funds into FY 16/17. He

suggested approving Budget Scenario 2 with an amendment to grant RUHS's request for approximately \$1.06M in contingency funds. After discussion, Steve Harmon, Stan Sniff, and Dave Brown agreed that an amended Scenario 2 would best fit the current budget situation.

Mark Hake made a motion to adopt Budget Scenario 2 and also grant RUHS's request for contingency funds in the amount of \$1,059,282. The motion was seconded by Dave Brown. The motion passed as follows:

#### 5. <u>Budget Presentations</u>

- a) Doug Moreno reviewed the FY 16/17 Estimated Available Funding (handout) as follows:
- FY 16/17 Riverside Co Estimated Share of Statewide Allocation \$70.14M
- FY 15/16 Riverside Co Estimated Share of Growth Funding \$4.30M
- FY 15/16 CCPEC Projected Carry Forward Balances \$5.95M
- Total FY 16/17 Estimated Available Funding \$80.39M

He added that if all CCPEC agencies remain "status quo" and request the same funding amounts as in FY 15/16 for FY 16/17, there is a projected shortfall of \$2.94M.

- b) Probation Budget Presentation Chief Deputy Ron Miller thanked the Probation staff who assisted in preparing the budget presentation. He then introduced the Riverside County Probation Department FY 16/17 Proposed Budget with the following data (handout):
- Supervision Stats as of April 30, 2016:
  - Active Post-release Community Supervision (PRCS) Offenders 1,741
  - Active Mandatory Supervision Offenders 1,134
- Supervision Staff as of March 2016:
  - 23 High Risk caseloads with an average of 40 cases per probation officer
  - 18 Medium Risk caseloads with an average of 60-75 cases per probation officer
  - 3 Low Risk caseloads with an average of 120-250 cases per probation officer

Division Director Maria Barajas reviewed the programs available through the Day Reporting Centers (DRCs) in Riverside, Temecula and Indio. To date there are over 7,746 classes/services provided to 1,506 offenders. Future DRC plans include increasing continued education through community colleges and promoting employment opportunities through vocational programs. Maria Barajas also reviewed the Transition and Re-entry Unit (TRU) expansion of resources to include offenders at all the County jails. The main goal of TRU is to create a seamless transition in supervision after an offender is released into the community. There are currently 59 active TRU participants and the offender reporting rate is 95%. Future TRU plans include earlier collaboration with Behavioral Health and maximized coordination with the assigned field probation officers and DRC staff. There was discussion on how the department determines the success of its programs. Typically, Probation determines success by the completion of the current offender's term without committing a new offense.

Doug Moreno reviewed Probation's approved realignment budget for FY 15/16 which totaled \$20.6M. The Proposed Budget for FY 16/17 totals \$21.2M, which is an increase of about \$600,000 to cover salary and benefit increases for the current staff. No new staff is requested.

c) District Attorney Budget Presentation – Supervising Deputy District Attorney Vincent Fabrizio reviewed the Riverside County District Attorney CCPEC Budget Request for FY 16/17

PowerPoint and Proposed Budget (handout). He reported that since the implementation of AB 109, prosecutors took on additional roles including enforcing violations of Supervised Release "Split Sentence," enforcing violations of parole, and participation in the Post-release Accountability Compliance Teams (PACT).

Vincent Fabrizio reported that as of April 30, the District Attorney's Office has 791 parole violations which will shortly surpass the numbers for FY 14/15. There was discussion regarding the inclusion of Prop 47 cases in the AB 109 budget presentation. Vincent Fabrizio explained that some of the Prop 47 cases belonged to AB 109 offenders. He also reviewed the District Attorney's Office participation on the PACTs and advised the teams need additional resources from their office. He proposed the updated staffing below which reflects the true needs of his department:

#### Proposed FY 16/17 Staffing:

- 1.25 Deputy District Attorney IVs (currently 2.2 Deputy District Attorney IIIs)
- 4 Senior DA Investigators (currently 3 Senior DA Investigators)
- 4 Victim Service Advocates (currently 4 Victim Services Advocates)
- 3.35 Legal Support Assistants (currently 2.35 Legal Support Assistants)
- 1 Investigative Technician (new request)

Vincent Fabrizio reported they are asking for additional staffing but their overall budget request has been reduced from the previous fiscal year. They have a proposed FY 16/17 total budget of \$1,750,289; of which \$707,700 is requested funding from the CCPEC with the remainder to be funded out of their separate state allocation. There was discussion on the history of the PACTs and the District Attorney's Office workload on the teams. Mark Hake indicated this is the first time he is hearing of the need for additional DA staffing on the Eastern PACT. He also requested data on additional filings to support the staffing increase.

d) Public Defender Budget Presentation - Steve Harmon reviewed the FY 16/17 AB 109 presentation dated May 24, 2016 (handout). He advised they are requesting \$90,663 less than was approved in the budget for FY 15/16, and will maintain the same level of personnel. The caseload numbers have stabilized and are being effectively handled by the current staff.

The following staffing levels are proposed for FY 16/17:

- Deputy Public Defenders 2 for PRCS and Parole cases; 3 for 1170(h) cases
- Legal Support Assistants 2 for PRCS and Parole cases; 2 for 1170(h) cases
- Social Service Workers 2 for PRCS and Parole cases
- Paralegals 3 for 1170(h) cases

Steve Harmon stated they have a proposed FY 16/17 budget of \$1,770,188; of which \$727,599 is requested funding from the CCPEC and the remainder to be funded out of their separate state allocations.







- There are 178 inmates in custody who are sentenced to 3 years or more
- Longest sentence: 13 years

3056 PC (Parole Violation) – Period of detention in a county jail due to a violation of an offender's condition of parole.

3454 PC (Flash Incarceration) – Period of detention in a county jail due to a violation of an offender's condition of post release supervision (1-10 days).

3455 PC (PRCS) – Period of detention in a county jail due to a violation of an offender's condition of post release supervision (not to exceed 180 days)

1170(h) PC – Sentenced felony offenders serving their time in a county jail as opposed to state prison.



## Jail Overcrowding and Early Releases

#### Federal Court Ordered Release breakdown:

- 32,236 inmates have been released early since the inception of AB109
- 3,286 inmates were released early in 2015
- So far in 2016, early releases are currently tracking at a higher rate than 2015.




## **Proposition 47 Impact**

- Took effect on November 5, 2014.
- Riverside County jails have remained at maximum capacity.
- Drug and Property crime bookings initially declined but are now rising back to near Pre-Prop 47 levels.
- As of May 31, 2016, 5,500 inmates have been released early since the Proposition 47 took effect




## **Proposition 47 Impact**

Federal Release and AB 109 Inmates January 2014 - May 2016









## Seriously Mentally Ill Housing Units

- This Fiscal Year 128 beds were converted for mental health housing.
- We currently have 362 beds dedicated for seriously mentally ill inmates. (229% increase since Pre AB 109)



## Seriously Mentally Ill Housing Units

- SCF transitional mental health housing (192 beds).
  - 6 individual dayrooms within one housing unit constructed like spokes on a wheel.
  - Inmates progress from the most restrictive dayrooms to dayrooms which allow greater privileges as their behavior and condition improves.
  - Forensic Behavioral Health staff provides therapeutic treatment with the goal of reintegrating the inmates back into the general jail population and/or community.



## **Homeless Outreach Program**

- The Riverside County Sheriff's Department Homeless Outreach Team (HOT) was created January 21, 2016.
- Patrol Division's Role
  - 2 Patrol Deputies (Jurupa Valley Station) permanently assigned to the program with liaisons assigned at every station.
  - Responsible for addressing homeless issues within all communities served by the Department.
- Correction's Division Role
  - Interview Process
  - Information collected assists the Homeless Outreach Team in providing resources to the homeless within Riverside County.

## **Budget Request**

- FY 15-16 budget request of 32.9 million was based on continued systematic impact, one-time costs for Mental Health Housing remodel, and additional Mental Health Housing Unit overtime costs.
- FY 16-17 budget request includes salary and benefits for existing 135 Board approved AB109 positions in addition to the conversion of 10 previously funded overtime positions for Mental Health Housing Unit to FTEs.

## Riverside University Health System AB109 Services

RUHS Correctional Health and Behavioral Health provide basic and emergency medical, dental, and behavioral health care to AB109 inmates at the five county jails.



RUHS Behavioral Health provides mental health and substance use services to AB109 clients at county operated clinics and probation day reporting centers Services including: Mental Health Outpatient, Substance Use Outpatient, and contracted placement services.



RUHS Medical Center and Care Clinics provide a full variety of inpatient and outpatient care to AB109 clients including: radiology, CT scans, laboratory, respiratory therapy, physical therapy, EKC, and emergency room services.

## AB109 Behavioral Health Services

RUHS – Behavioral Health offers mental health and substance use services to AB109 clients. Services include intensive treatment teams, mental health outpatient, substance use outpatient, and contracted placement services.

- 160 Intensive Treatment Team Clients
- 2,836 Behavioral Health Outpatient Clients



## Behavioral Health Intensive Treatment Teams

RUHS – Behavioral Health Intensive Treatment Teams provide AB109 clients access to any service necessary to support their mental health recovery. Clients will receive an array of services including but not limited to mental health crisis, mental health outpatient, medication, physical health, vocational, housing, transportation, and substance use services.





In FY 15/16 160 clients were served through this intensive wellness and recovery based program.

## Behavioral Health Outpatient Services

RUHS – Behavioral Health Outpatient Services is comprised of both mental health and substance use services. Services are provided in county operated clinics, probation day reporting centers, and by contract providers. In total, 2,836 AB109 clients received services in FY 15/16.






1,347 clients received mental health assessments, outpatient services, medication, peer recovery services, education and vocational services.

1,489 clients received substance use screening, outpatient drug free, narcotic treatment, case management, HIV testing and education, and residential services.

## Behavioral Health Contracted Placement

RUHS – Behavioral Health Contracted Placement services provide emergency, transitional and permanent housing solutions for AB109 clients. These services also provide crisis residential treatments services and when necessary psychiatric hospitalizations at the appropriate inpatient level of care.





#### FY 15/16 AB109 Services

- 600 total contracted placement clients
- 400 housing services clients
- 99 short term mental health crisis residential treatment clients
- 81 psychiatric hospitalizations
- 21 institute for mental disease/other locked facility clients

## Behavioral Health Inmate Care

- RUHS Behavioral Health also provides behavioral health screenings, mental health services and substance use health care to AB109 inmates at the five county jails.
- Started severely acute housing units in both Smith and RPDC



FY 15/16 AB109 Services

- 1,873 Behavioral Health Clients
  - 2,300 Behavioral Health Screenings
  - \$5m annual expenditures, within budget target.

## Correctional Health Inmate Care

RUHS – Correctional Health and Behavioral Health provide basic and emergency medical, dental, mental health and substance use health care to AB109 inmates at the five county jails.



FY 15/16 AB109 Services

- 14,509 Correctional Health Visits
  - 5,368 Physician/Nurse Practitioner Visits
  - 9,141 Nursing Visits
  - 8,100 Medications dispensed
  - \$7.7m annual expenditures, \$4.9m over budget.

# Inmate Care Improvements to Staffing Ratios (Correctional and Behavioral Health)

Correctional and Behavioral Health are in the process of increasing staffing in order to meet the increasing health demands of inmates staying longer in our jails.



#### FY 16/17 Additions

- Correctional Health adding 129 additional positions. Estimated FY 16/17 AB109 impact is approximately \$1.9m above FY 15/16 expenditure level.
- Behavioral Health adding 84 positions. Estimated FY 16/17 AB109 impact is approximately \$2m.



## AB109 Medical Center Services-Hospital

RUHS - Medical Center offers a full array of health care services to AB109 clients. Services include radiology, CAT scans, laboratory, respiratory therapy, physical therapy, EKC, and emergency room services.



FY 15/16 AB109 Services

- 1,758 inpatient bed days
- 1,567 outpatient visits
- 135 psychiatric emergency room visits
- 113 inpatient psychiatric holds
- \$4.5m annual expenditures, \$258k under budget.

FY 16/17 Budget Request

- Requesting support at the FY 15/16 funding level of \$4.7m.
- No increases in budget
- COLA/ISF increases absorbed



## FY 16/17 Budget Request Summary

RUHS will attempt to absorb COLA and ISF increases within all budget areas except the jails. Due to the built in budget shortfall from FY 15/16 and significant increases in required healthcare service levels within the jails, expenditure increases were unavoidable. In total RUHS is requesting \$32.3 million in AB109 support, an \$8.9 million increase above the approved FY 15/16 budget.
