**1. CALL TO ORDER – ROLL CALL**

The meeting was called to order by the Chairman, Chief Probation Officer Alan Crogan at 1:31 p.m.

**2. APPROVAL OF MINUTES**

Alan Crogan entertained a motion to approve the January 24, 2012 minutes of the Community Corrections Partnership Executive Committee (CCPEC) meeting. Motion was moved by Gary Windom, and seconded by Patrick Williams. Alan Crogan requested a roll call vote of the motion which passed as follows:

**3. BUDGET STATUS REPORT– ACTION ITEM**

Alan Crogan reminded the committee that this reporting period was for a nine month budget that was given an allocation for six months with the exception of the unspent money going into the reserves and money not spent would be rolled over into the next year. He encouraged the District Attorney and the Public Defender to spend the state allocation first and the county allocation second. Alan Crogan further requested that the Fiscal Work Group reconvene as necessary to refine the data that was collected for each agency's budget. He explained the importance of why the agency's need to be consistent on how the data is presented.

Chief Deputy Probation Administrator Rosario Rull reported that this was the first effort in compiling the Budget Status Report for the first quarter report and that it was understandably

difficult for the agencies to estimate what they will be spending based on the first 3 months, out of a 9 month implementation. She stated that the agencies are reporting that they have money left over to be rolled over into the next fiscal year, except for Mental Health who projected they will spend their entire budgeted allocation. She further reported that some agencies are having difficulties tracking the actual cost and have not fully identified clients and the services that the clients may need. Administrative Services Manager Doug Moreno reviewed the summary report and reported that the next Quarterly Report will be due on April 16<sup>th</sup>.

Alan Crogan entertained a motion to accept the Fiscal Procedures Work Group recommendation motion #1 to receive and file the FY 2011/12 Financial Report- Summary of Expenditures (Schedule A) and the individual CCPEC Agency Financial Reports included in the meeting packet. Motion was moved by Alan Crogan and seconded by Stan Sniff. Alan Crogan requested a roll call vote of the motion which passed as follows:

#### 4. FINAL IMPLEMENTATION PLAN – ACTION ITEM

Alan Crogan informed the committee that the Final Implementation Plan was complete and ready to be presented to the Board of Supervisors on February 28, 2012. Alan Crogan suggested that December be the month that the committee start updating the next Final Implementation Plan for 2012 and February be the set month that the Final Implementation Plan is completed each year.

Alan Crogan entertained a motion to approve the AB 109 Final Implementation Plan as submitted. Motion was moved by Patrick Williams and seconded by Gary Windom. Alan Crogan requested a roll call vote of the motion which passed as follows:

#### 5. STAFF REPORTS – DISCUSSION ITEMS

a) CHIEF OF POLICE: Patrick Williams reported that four out of six positions have been filled and the other two will be in place on February 9, 2012. He further reported that the letter regarding data sharing among law enforcement was given to County Counsel last week. Deputy County Counsel David Huff stated that the letter looked acceptable and was in compliance with Penal Code 13300 (b). Patrick Williams explained that the letter will be presented to the Association of Riverside County Chief of Police (ARCCOP) committee. Paul Zellerbach informed that he asked his Rights and Appeals Unit to do a legal analysis of the concerns regarding data sharing between law enforcement and probation. He stated that they produced a legal memorandum from his office. Chief Deputy Probation Officer Bryce Hulstrom stated that Probation Department will provide a liaison from the Banning Probation office to the task force in March. The liaison will be able to provide the task force with information regarding AB 109 releases.

b) COURT: Not in attendance.

- c) DISTRICT ATTORNEY: Assistant District Attorney Creg Datig expressed that the District Attorney's office is in concurrence with the Public Defender's Office with regards to the PrCS proceedings. He further explained that he is hoping to work with other organizations to foster a clean-up of AB 109.
- d) MENTAL HEALTH: Assistant Director Donna Dahl reported on behalf of Jerry Wengard. She reported that October 1, 2011 through February 2, 2012, there have been a total of 215 referrals.
- 59 Substance Abuse
  - 102 Mental Health
  - 22 Health
  - 3 referred out of the county
  - 14 refused any referral
  - 15 other referrals

Donna Dahl stated that there are continued discussions on how they can track this population. The Health & Human Services committee is working on a screening form to help with doing a more systematic screening for health, mental health and substance abuse problems. Training will be provided for Probation and the Sheriff's Departments to review the basics on what services are available through DPSS, Mental Health, Health, and Hospital.

- e) PROBATION: Division Director Bill Palmer distributed and reviewed the AB 109 Statistics, dated as of February 3, 2012.
- Total packets received from CDCR: 1,727
  - Number of intakes completed: 1,506
  - Number assigned to supervision: 1,019
  - Post-Release Community Supervision (PrCS): 933
  - PrCS Warrants: 65
  - Revocation Petitions: 188

Bill Palmer also reviewed the PrCS Population by City and made reference that there are 267 homeless PrCS offenders as of February 6, 2012.

- f) PUBLIC DEFENDER: Gary Windom reported that they are continuing with the hiring process and adapting their case management system to accurately track the AB 109 cases and the split sentencing.
- g) SHERIFF: Stan Sniff shared that he will meet with the state sheriffs and discuss the status of the other counties. Chief Deputy Jerry Gutierrez distributed and reviewed the AB 109 Impact Update as followed:
- CDCR Commit Parole Revocation (Pre October 1, 2011) - 59 inmates
  - Riverside Sheriff's Department Commit Parole Revocation (Post October 1, 2011) - 1,686 inmates
  - Flash Incarceration - 35
  - PrCS Violation - 79
  - Total Sentenced Commitments - 2,885 inmates
  - AB 109 Impact - 1,745 inmates



Jerry Gutierrez further explained that there are no pre-trial or electronic monitoring as of yet. Paul Zellerbach expressed concerns on the release of inmates before pre-trial. Jerry Gutierrez and Undersheriff Colleen Walker explained the process and that the Sheriff's Department is exercising all mechanisms. Stan Sniff added that this is a problem for the jail system and triaging of inmates. Assistant Sheriff Steve Thetford also stated that it is a problem because of the way the statutes read and they are fully aware of the information issue but are continuing to work on it. Jerry Gutierrez stated that he will be meeting with the Court regarding alternative sentencing.

6. WORK GROUP REPORT – DISCUSSION ITEM

Bill Palmer distributed and reviewed the work group report as requested from the last CCPEC meeting on January 27, 2012. Gary Windom thanked Bill Palmer for providing the information from the work groups in writing.

7. ALTERNATIVE SENTENCING PRACTICES - DISCUSSION ITEM

Alan Crogan asked for this agenda item to be tabled until further information is provided.

8. CANCELLATION OF THE FEBRUARY 21, 2012 CCPEC MEETING – ACTION ITEM
