APPROVAL OF MINUTES OF MARCH 26, 2018 MEETING:

Chief Probation Officer Mark A. Hake entertained a motion to approve the March 25, 2019 minutes of the Juvenile Justice Coordinating Council (JJCC) meeting. Motion to accept the minutes as submitted was made by Jitahadi Imara, Counsultant, Studentnest, seconded by Norma Biegel, Grant Manger, Operation SafeHouse.

Minutes were approved unanimously. Oppositions/Abstentions: None.

PROGRAM UPDATE:

LaToya Thomas, Assistant Director, Special Services Division, Riverside County Probation Youth Accountability Team (YAT):

- Program consists of 21 Youth Accountability Teams (YAT) county-wide serving 15 school districts. There is approximately 50 staff working in the YAT program from 9 different agencies.
- YAT is a voluntary program for the youth and the parent/legal guardians.
- As of June 30, 2019, 128 youth were in the program. Between April 1st through June 30th 2019, there have been 471 referrals to the program. Of the 471 referrals, 51 (11%) were placed on contract, 71 (15%) were counseled and closed, 102 (22%) were placed on

- consequence agreement, and 4 were provided diversion classes, serving approximately 48% of the referrals. The remaining 243 referrals were either ineligible for the program pursuant to 654.3 WIC, were unable to locate, or declined to participate.
- Field trips and pro-social events continue to be an important component of the program in an effort to expose the youth to different ideas, healthy activities and potential professions.
 Since April, YAT has planned numerous such fieldtrips and activities during school breaks, weekends and holidays to include places such as the March Air Field Museum, March Air Reserve Base, the Living Desert, Riverside Art Museum (RAM), and Angel's Stadium.
- To equip parents with the skills and techniques to respond to difficult adolescent behavior, YAT continues facilitating Parent Project classes throughout the county. During this reporting period, two sessions were conducted.
- YAT hosted two Youth Strength Academies this summer, one in the desert, which was held at the College of the Desert, and one on the western side of the county held at the University of California, Riverside. This year's theme was "Live Your Best Life." The desert had 24 and Riverside had 40 youth graduate. Presentations and information regarding various career paths, hobbies, and healthy decisions were the central focus of both YSAs. Several motivational speakers were utilized to convey these messages. Activities/presentations included: a culinary arts lesson, volleyball, big ball soccer, a clean comedy show, an escape room activity, the SoCal Coyotes Football presentation, an automotive presentation, and the UCR Ropes challenge course, to name a few. The youth seemed to have a good time.

Tattoo Removal:

- There continues to be four Tattoo Removal vendors providing services to youth age 14-17 ½
 years old. Currently two providers are in the Desert region (Contour Dermatology and
 Cosmetic Surgery Center and Scar Treatment Recovery Center) and two are in the Riverside
 region (Fountain of Youth Medical Spa and Sublime MD/Advanced Dermatology).
- Since our last report in March, two youth did not complete the program (1 family did not follow up with services; another youth had medical issues preventing program completion).
- Currently, there are 4 minors receiving services; 2 in Riverside and 2 in the desert.
- Services remain open to all Riverside County youth.
- Probation's Facebook page post regarding tattoo removal has been the department most viewed post over the last year: 107,600 people "reached," 26, 178 "engagements", 848 "shares" and 353 "likes".
- Continual effort has been made to advertise/promote the program at several school sites and collaborative meetings.
- Gerry Lopez suggested that Probation consider enlarging the scope to providing tattoo removal services to ages 14-25 years old. This would accommodate those seeking an opportunity for a life change and a future career i.e. military guideline. Chief Hake stated program scope and budget would be reviewed, and further discussion will be conducted at the November 4, 2019 meeting.

Restorative Justice (Victim Mediation):

- The program is a collaborative program between Chapman University and Riverside County Probation Department.
- This is the third year of a five year contract funded by the JJCC.

- Since our last report in March, there has been an additional 14 cases mediated, bringing the total since inception of the program to 75 mediations.
- Of the total 75 mediations, 54 have been closed, 18 remain open, and 3 were not settled. Of the 54 closed cases, three have committed a new law offense warranting court intervention. As such, the success rate of mediations is currently 94.5%.
- Attitudinal surveys are used to receive feedback from those having gone through the
 program. Both the victims and offenders have been overwhelmingly positive and
 complimentary of the program. Victims reported their appreciation for the opportunity to
 sit down with the offenders and be heard, and offenders reflected on the importance of
 them being able to apologize directly to the victims.

Successful Short Term Supervision (SSTS):

Overview of SSTS Caseloads:

- On May 01, 2018, our department began the Successful Short-Term Supervision project with the overall goal of assisting the youth and their parents to successfully complete probation by their first review hearing. Specifically, the goal is to provide appropriate supervision to assist with the youth's improvement in school attendance/performance, abstinence from alcohol/substance abuse, participation in appropriate counseling (based on their needs), positive community involvement through community service and/or participation in pro-social activities.
- Some intervention strategies include reduction in time for probation's first appointment to meet with youth and family, youth are seen within fifteen day of dispositional hearing, mandatory attendance in four week follow-up Child Advocate Team (CAT).
- Monthly contact is in accordance with supervision level standards. Most youth are seen once to twice per month.
- Probation Officer is present at review hearings when the recommendation is for an extension of probation or recommendation for unsuccessful completion (revoke 654, lift DEJ, or declare ward).

Outcome Measures

- Success Completion of probation at first review hearing.
- Success With extension, still a success, but amount of time extended is tracked.
- Not Successful Probation revoked, DEJ lifted, 725 violated and declared a ward and/or if new law violation occurs after completion of probation within 6 months.



• A comparison between SSTS and Non-SSTS cases demonstrates that since May 31, 2019, 76% of the SSTS participants terminated probation successfully. Whereas, with Non-SSTS cases, the success rate was 64%.

Recidivism Comparison:

Rate of New Arrest within 6 months of Successful Termination of SSTS



As of May 31, 2019, there were 216 former SSTS participants who had successfully completed the program at least six months prior. 193 of these (89.4%) had no record of a new arrest or referral to the Riverside County Probation Department six months after completing SSTS; 23 (10.6%) had a new arrest within 6 six months of successfully completing SSTS.

Danny Feltenberger, Captain, Riverside County Sheriff's Department

- GIFT is a preventive gang intervention program that focuses on middle school aged teens.
- Between March 2019 to June 2019, 58 families were contacted for intervention, 6 signed up for intervention, 2 successfully completed GIFT, and 28 families are currently participating in GIFT.
- Between March 2019 to June 2019, personnel spent 284.5 hours on family interventions.

Gerry Lopez, Supervising District Attorney, County of Riverside District Attorney Gang Awareness Mentorship & Education (GAME) Program:

- The program is designed to reach at-risk youth within our county in an effort to intervene and prevent gang affiliation.
- Program offers education, communication and community outreach with gang awareness presentations, and outreach through schools for students grade levels 4th-12th.
- The program provides resources, parenting tips, warning signs and why kids join gangs.
- April through July, 2019, the GAME program provided 66 presentations to approximately 6,755 people which includes 6,180 youth. These presentations included Gang Awareness, Drug Awareness, and Parent Power presentations.
- CPS referred a student to the Eastern Division GAME mentorship program in the desert. The student was referred because he was failing all of his classes, drug usage, and was not on track to graduate. After the six months of GAME mentorship, the student stopped using drugs, passed his classes, and graduated with his senior class.

SB 439 COMMITTEE UPDATE:

Jitahadi Imara, Committee Chairperson (StudentNest Foundation):

At the January 8, 2019 meeting, the Juvenile Justice Coordinating Council establishes an AD Hoc Committee to develop a plan of action to address Senate Bill (SB) 439. In response, the SB 439 AD Hoc Committee is proposing the following as Riverside County's plan and response to the SB 439 legislation:

- SB 439 Protocol: The Protocol is a guide for referring children under 12 years of age who meet the criteria for SB 439 services (see handout).
- Established SB 439 Clearinghouse for Notification of Services: Riverside County Office of Education will serve as the central point of contact for notification of SB 439 referrals and services.
- School SB 439 Pilot: Alvord Unified School District (AUSD) and Riverside County Office of Education (RCOE). The Committee will oversee the pilot of one school from AUSD and one school from RCOE, beginning August 12, 2019 and concluding November 8, 2019. The purpose of the pilot will be to vet the SB 439 Protocol and gather data that will inform the full implementation of the protocol on January 1, 2020.

- Riverside University Health System and JJCPA Funded CBOs (volunteers) will be service providers for SB439.
- Next Steps:
 - School Pilot implementation meeting July 29, 2019.
 - Develop plan and strategy for notification of agencies impacted by SB 439 Protocol.
 - Continue to map resources for SB 439 services.
 - Schedule training for SB439 service providers.
 - Discuss and approve referral form.
