Custody Commitment Time

940.1 PURPOSE AND SCOPE

The purpose is to establish and implement written policy and procedures concerning custody commitment time. This policy applies to all juvenile facility staff.

940.3 POLICY

Youth ordered by the juvenile or adult court to serve custody commitment time shall be detained in accordance with the court's order.

940.4 TIME ORDERED

When the juvenile court orders a minimum and maximum amount of time to be served, Probation staff shall enter the custody commitment time and any credit for time served into JAMS. JAMS will configure the projected minimum and maximum release date. Youth shall be notified of the minimum and maximum amount of custody commitment time ordered, including credit for time served. Youth and staff shall sign a Custody Commitment Time Notification (attachment). Staff shall provide youth with a copy and place the original in the youth's facility file.

940.5 EXTENSION OF CUSTODY COMMITMENT TIME

Custody commitment time for youth who are the subject of major discipline can be extended beyond the minimum confinement time up until the youth's maximum confinement time. Any extension of custody commitment time shall be reviewed and approved by the facility manager(s), or designee, and in accordance with Policy 976: Incentives and Discipline process. The youth's attorney shall be notified when custody time is extended and documented on the Custody Commitment Time Extension Form (attached.)

Documents pertaining to the extension of confinement shall be retained in accordance with Policy 959: Storage/Destruction of Files, Logs, Reports and Records.

- D. Assault
- E. Inappropriate Sexual Behavior
- F. Sexual Assault
- G. Battery
- H. Vandalism/Destruction of County Property or Fire Setting
- I. Persistent or Established Pattern of Repetitive Rule Violations or Refusal to Obey Directives
- J. Fighting
- K. Unlawful Behavior
